## **FAYETTE GUN CLUB WAIVER AND RELEASE FROM LIABILITY AGREEMENT**

1) By signing this Waiver And Release From Liability (Agreement), I waive and release Fayette Gun Club (in Fayette County, PA), its agents, servants, employees, insurers, successors and assigns from any and all claims, demands, causes of action, damages or suits at law and equity of any kind, including but not limited to claims for personal injury, property damage, medical expenses, loss of services, on account of or in any way related to or growing out of my presence or involvement at the facility.

This waiver and release is intended to and does release Fayette Gun Club from any and all liability for damages or injuries on account of or in any way related to or growing out of my negligence, the negligence of third parties and Fayette Gun Club's negligence. This is not intended to release Fayette Gun Club from any liability resulting from their intentional conduct.

I further covenant and agree not to institute any claims or legal action against Fayette Gun Club for any claim released by this Agreement. I further agree that should any claim be made against in contravention of this Agreement, including but not limited to derivative claims, I will protect, defend, and completely indemnify (reimburse) Fayette Gun Club for any such claim and expenses including attorney's fees and costs incurred by Fayette Gun Club in defending themselves or security indemnify hereunder.

2) I understand that Fayette Gun Club is not responsible for any lost, stolen, or damaged, valuables or property.

3) I acknowledge that I have received and read a copy of the current rules and regulations governing the use of the facility. I agree that I will fully comply with all rules and regulations and any amendments.

I have read the Agreement and understand that by signing the Agreement I have consented to be bound by its terms, including the waiver/release of any legal right I may have to sue Fayette Gun Club for any costs they incur because a claim or legal action is brought in violation of this Agreement.
